Dear Exhibitor:

We would like to invite you to be represented among the exhibitors at the annual family conference of the Independent Baptist Fellowship of North America held on June 16-18, 2015. The conference will be meeting at Marshall Baptist Church, 5739 Old Rural Hall Road, Winston-Salem, NC 27105, (336) 767-2595. Our theme this year is "Occupy Till I Come." Article II from the IBFNA Constitution defines the purpose of the IBFNA:

II. Purpose

Recognizing the need for a national fellowship of fundamentalist, separatist Baptists, we have organized for the following purposes:

- A. To establish a nationwide fundamentalist, separatist association of Baptists to provide fellowship, counsel, a uniform standard of biblical faith and practice, and a vehicle for cooperation in promoting the evangelistic, church-planting and educational goals of the fellowship; and further
- B. To emphasize the biblical teaching on separation from unbelievers in religious work (primary separation) and separation from believers who ignore or disobey the Bible's teaching of primary separation (secondary separation); and
- C. To raise a standard for personal separation from worldliness and worldly practices reflecting the truth that believers are new creatures in Christ; and
- D. To provide information on current issues facing fundamental Baptists and others; and
- E. To produce literature for churches and pastors who desire such materials.
